Manuel Rama Montaldo graduated as Doctor of Law and Social Sciences from the University of the Republic in Montevideo, Uruguay, specializing in Public International Law and International Organizations at the University of Oxford, England (British Council Fellowship) and, subsequently, through International Law Fellowships granted by UNITAR and UNESCO. He has taught Public International Law at the University of the Republic and at ORT University, Uruguay. He has also lectured or been a panelist on International Law topics at universities or other institutions of the United States, France, Switzerland, Italy, The Netherlands, England, Egypt, Canada, Brazil Trinidad and Tobago, Venezuela and China.

He has worked for almost 28 years for the Codification Division of the Office of Legal Affairs at the United Nations Secretariat, first as a Legal Consultant and later, as Deputy Director for Research and Studies and Deputy Director of the Division. In these capacities, he has been closely involved with the work of various United Nations organs dealing with the codification and progressive development of International Law, such as the International Law Commission (Geneva), the Sixth (Legal) Committee of the General Assembly, the Special Committee on the Charter of the United Nations and the Strengthening of the Role of the Organization, the Ad Hoc Committee on International Terrorism, etc. (New York) and of other bodies or gatherings such as the Working Group on the Decade of International Law, and the Congress of International Law. He has also been for many years Executive Secretary of the United Nations Programme of Assistance in the Teaching, Study, Dissemination and Wider Appreciation of International Law and participated in the United Nations Conference for the Establishment of an International Criminal Court (Rome). After his retirement from the United Nations he has been a Consultant for the International Criminal Court (The Hague).
