Professor Monteagudo earned his law degree from the Pontifical Catholic University of Peru (PUCP), his LLM from the University of Houston and his Doctorate in Laws from the University of Paris I, Panthéon Sorbonne. His doctoral dissertation focused on the topic of the independence of the central bank (published in 2010). He is member of the Committee on International Monetary Law of the International Law Association (MOCOMILA) and the Society of International Economic Law.

Professor Monteagudo is currently the General Counsel of the Central Bank of Peru, having held various positions in the Bank, such as Secretary General, Assistant Lawyer for the Board's Counsel and Legal Counsel for the International Division. In 2004 he was representative of the Central Bank before the National Pact on Investment and Employment a forum where different public and private institutions -including political parties, unions, civil society and private investors- proposed a long-term plan to promote investment and employment under an open market approach and the respect of the rule of law.

At the PUCP Mr. Monteagudo is professor at the Department of Law and the LLM Program on International Economic Law. He has been member of the Law School Board (2014 – 2017) and Director of the LLM Program (2014 – 2016). He was visiting Professor in the University of Stockholm (May 2010), teaching the seminar: "Legal Issues on International Economic Law: A Latin American Perspective" (Linneus-Palme Exchange Program).

He has participated as speaker in forums organized by the International Monetary Fund, the Bank for International Settlements and the Centro de *Estudios Monetarios Latinoamericanos*. He is author of several publications in the area of international economic law, such as:
