Introduction

1. This document is intended to supplement - and to be used in conjunction with - the Bibliographical Guide to the Law of the Sea (A/CONF.13/17 of 21 November 1957) which was prepared for the use of the first United Nations Conference on the Law of the Sea.
2. A number of omissions have been rectified; and some minor corrections have been incorporated. Attention is drawn to the observations contained in paragraph 2 of the introduction to the 1957 Bibliographical Guide. Similar considerations apply to this supplement.
3. The arrangement of the present document adheres as far as possible to that of the 1957 Bibliographical Guide. Thus, Section II (Monographs on the law of the sea) includes monographs on particular aspects of international law which contain passages relating to the law of the sea, in addition to works devoted entirely to a part or the whole of the topic of the law of the sea. However, in the absence of new material, Section V of the 1957 Bibliographical Guide (General works on diplomacy and international law) has been replaced by a section entitled "Official publications", which lists works produced under governmental or United Nations auspices. Recent contributions to the Recueil des Cours of the Hague Academy of International Law will be found in Section IV (Articles in periodicals (List)).

Introduction

1. Le présent document est destiné à compléter le Guide bibliographique pour l'étude du droit de la mer (A/CONF.13/17, 21 novembre 1957) préparé pour la première Conférence des Nations Unies sur le droit de la mer.
2. Un certain nombre d'omissions ont été rectifiées et quelques corrections mineures ont été faites. Les observations qui figurent au paragraphe 2 de l'introduction au Guide bibliographique de 1957 s'appliquent également au présent supplément.
3. On s'est efforcé dans toute la mesure du possible d'adopter la même présentation que pour le Guide bibliographique de 1957. Par exemple, dans la section II (Monographies sur le droit de la mer) figurent des monographies sur des aspects particuliers du droit international où sont reproduits des passages relatifs au droit de la mer, ainsi que des travaux entièrement consacrés au droit de la mer ou à certains de ses aspects. Toutefois la section V du Guide bibliographique de 1957 (Ouvrages généraux de diplomatie et de droit international) a été remplacée, faute d'ouvrages nouveaux, par une section intitulée "Publications officielles", où figure une liste d'ouvrages publiés sous les auspices des gouvernements ou des Nations Unies. Les articles parus récemment dans le Recueil des cours de l'Académie de droit international de La Haye sont indiqués à la section IV (Articles de revues (liste)).

Introducción

1. Este documento debe servir de complemento a la Guía bibliográfica (A/CONF.13/17 de 21 noviembre 1957) preparada para la primera Conferencia de las Naciones Unidas sobre el Derecho del Mar.
2. Se han rectificado algunas omisiones y se han incluido ciertas correcciones de poca importancia. Se señala la atención a las observaciones contenidas en el párrafo 2 de la introducción a la Guía bibliográfica de 1957. Las mismas consideraciones se aplican a este suplemento.
3. El presente documento está ordenado más o menos en la misma forma que la Guía bibliográfica de 1957. Así en la Sección II (Monografías sobre el derecho del mar) se incluyen algunos estudios de aspectos particulares del derecho internacional que contienen pasajes relativos al derecho del mar, además de obras dedicadas íntegramente a una parte o a todo el tema del derecho del mar. Sin embargo, a falta de nuevo material, la Sección V de la Guía bibliográfica de 1957 (Obras generales sobre la diplomacia y el derecho internacional) ha sido sustituida por una sección titulada "Publicaciones oficiales" en la que se enumeran los trabajos producidos con el auspicio de los gobiernos o de las Naciones Unidas. Las contribuciones recientes al Recueil des Cours de la Academia de Derecho Internacional de La Haya se enumeran en la Sección IV (Artículos aparecidos en publicaciones periódicas (listas)).
