I. Introduction

- 1. At its 2nd meeting on 7 December 1973, the Conference decided to establish the Third Committee as one of its three Main Committees.
- 2. During the third session of the Conference, held at Geneva from 17 March to 9 May 1975, the officers of the Committee were as follows:

II. Mandate of the Committee

3. The mandate of the Committee consists of examining the subjects and issues allocated to it by the Conference at its 15th meeting on 21 June 1974.89

III. Organization of work

- 4. During the third session of the Conference, the Third Committee worked through formal and informal meetings. It held 8 formal meetings and 23 informal meetings.
- 5. At its 18th meeting on 19 March 1975, the Committee accepted a proposal by the Chairman that the Committee should continue working under the established practice of holding informal discussions alternately on item 12 (Preservation of the marine environment) and items 13 (Scientific research) and 14 (Development and transfer of technology). The Committee would have formal meetings, when necessary, to enable delegations to introduce formal proposals. Those proposals introduced by delegations during the current session and other formal documents presented to the Committee are listed at the beginning of the present volume.
- 6. As at the previous session at Caracas, the informal meetings of the Committee when discussing item 12 were under the chairmanship of Mr. José Luis Vallarta (Mexico), and when discussing items 13 and 14, under the chairmanship of Mr. Cornel Metternich (Federal Republic of Germany).

IV. Work of the Third Committee at its informal meetings

- 7. The work undertaken at informal meetings during the current session is reflected in the following documents:
 - (i) item 12: document A/CONF.62/C.3/L.15/Add.1, which contains informally agreed common texts, and document A/CONF.62/C.3/L.30 and Add.1.
 - (ii) items 13 and 14: document A/CONF.62/C.3/L.31.

VI. Future work

9. The Third Committee made progress at the current session of the Conference towards completion of the mandate assigned to it by the Conference. It therefore recommends that the opportunity should be provided for it to continue its work at a further session or sessions with a view to completing the drafting of articles dealing with the preservation of the marine environment, scientific research and the development and transfer of technology.
