#### INTRODUCTION

1. This guide, which has been prepared in accordance with the practice followed for previous codification conferences, 1/ is designed to provide a set of references which is as comprehensive as possible and permits the reader to trace the development of thinking with regard to the draft as a whole and its various parts and with regard to its individual provisions. It begins with 1963, the year in which the Special Rapporteur submitted his first report. The introduction to this first report 2/ provides a brief summary of the events prior to 1963 which led the International Law Commission to include the question of relations between States and international organizations in its agenda.

2. The guide describes the work of the International Law Commission and the General Assembly as well as the comments which Member States and Switzerland, on the one hand, and the United Nations, the specialized agencies and IAEA, on the other hand, have on a number of occasions been invited to submit during the preparation of the draft. It should be noted in that connexion, however, with regard to the comments 3/ which the General Assembly requested Governments and international organizations to submit under paragraph 4 of its resolution 3072 (XXVIII), that only those comments received by 15 November 1974 could be taken into account.

3. It should be noted that the Secretariat has prepared on this question a note on the precedence of representatives to the United Nations,  $\frac{1}{4}$  observations concerning the various language versions of the provisional draft adopted by the Commission in 1968, 1969 and 1970, 5/ a note on the differences in form between part II and part IV of that draft  $\frac{6}{4}$  and, in particular, a study of the practice of the United Nations, the specialized agencies and IAEA concerning their status, privileges and immunities.  $\frac{7}{4}$  Although these documents served as background for the work of the Special Rapporteur, the International Law Commission and the General Assembly on this question, they are mentioned here for information only because of their descriptive character, which places them slightly outside the scope of this guide.

4. For simplicity of presentation, the documents referred to in the guide are not accompanied each time by their symbols. The table below gives the official title of each document (titles which often appear in abridged form in the guide) and, opposite, the symbol and any other relevant bibliographical information.
