#### INTRODUCTION

- 1. This Guide for the draft articles on succession of States in respect of State property, archives and debts which has been prepared in accordance with the practice followed for previous codification conferences 1/ is designed to provide as comprehensive a set of references as possible in order to permit the reader to trace the development of thinking with regard to the draft as a whole and its various parts and with regard to specific draft articles and questions. It begins with 1973, the year in which the Commission began the elaboration of draft articles on the topic "succession of States in respect of matters other than treaties". A brief summary of the proceedings of the Commission and the decisions of the General Assembly on the topic prior to 1973 is to be found in the report of the Commission on the work of its thirty-third session. 2/
- 2. The Guide covers the work of the International Law Commission and the General Assembly as well as comments which Governments submitted in writing at various stages of the preparation of the draft. 3/
- 3. The background material relevant to the question included the following documents prepared by the Secretariat:
- (a) A study entitled "Digest of decisions of international tribunals relating to State succession" 4/ and a supplement thereto; 5/
- (b) A study entitled "Digest of decisions of national courts relating to succession of States and Governments"; 6/
- (c) A volume of the United Nations Legislative Series entitled Materials on succession of States 7/ and a supplement to this volume; 8/
- (d) Another volume of the United Nations Legislative Series entitled Materials on succession of States in respect of matters other than treaties. 9/
- 4. For simplicity of presentation, the documents referred to in the Guide are not given their complete official title nor are they accompanied by their symbols. The table below indicates opposite the short title used in the Guide, the full title of the document in question as well as its symbol.
- 5. Since the Guide is essentially in the form of a list, it has been prepared in one language only in accordance with previous practice.
