ARTICLE 2(6)

TEXT OF ARTICLE 2(6)

The Organization shall ensure that states which are not Members of the United Nations act in accordance with these Principles so far as may be necessary for the maintenance of international peace and security.

INTRODUCTORY NOTE

1. The general structure of this study follows that of Article 2(6) in the *Repertory*, *Supplement* Nos. 3, 4, 5, 6 and 7.

I. GENERAL SURVEY

- 2. During the period under review, none of the decisions taken by the Security Council or the General Assembly for the maintenance of international peace and security referred explicitly to Article 2(6). Nor were any recommendations made by the Security Council or the General Assembly to specific non-member States with respect to the maintenance of international peace and security.
- 3. In this period, the Security Council adopted resolutions relating to Haiti,¹ the Libyan Arab Jamahiriya,² the situation in Bosnia and Herzegovina,³ the situation between Iraq and Kuwait⁴ and the situation in Rwanda,⁵ in which it, *inter alia*, called upon all States, including States not members of the United Nations, to act strictly in accordance with the provisions of those resolutions. Throughout the same period, the General Assembly adopted two resolutions under its agenda item, "The situation in the Middle East", in which it, *inter alia*, urged non-member States to act in accordance with the provisions of the resolutions.⁶

4. Many resolutions adopted by the Security Council and the General Assembly with respect to the maintenance of international peace and security may be said to bear upon Article 2(6) inasmuch as they were addressed to "all States," "States," "each State,"

- "1. Call[ed] upon all States to intensify their practical efforts towards ensuring international peace and security in all its aspects through co-operative means in accordance with the Charter of the United Nations;
- "2. *Reaffirm[ed]* its support for the validity and relevance of the Charter and urge[d] all States to abide by it and, in particular, to respect the principles of sovereign equality, political independence and territorial integrity of States and non-intervention in internal affairs, refrain from the threat or use of force inconsistent with the Charter, settle disputes peacefully, adhere to the principles of equal rights and self-determination of peoples, respect for human rights and fundamental freedoms, and co-operation among States, and comply in good faith with their obligations assumed in accordance with the Charter".⁵⁸
- 6. The General Assembly adopted four resolutions under its agenda item, "Review of the implementation of the Declaration on the Strengthening of International Security", which contained similar language.⁵⁹ In the first of those resolutions, the General Assembly, *inter alia*:
 - "2. *Urge[d] once again* all States to abide strictly, in their international relations, by their commitment to the Charter of the United Nations;

"

- "4. *Call[ed] upon* all States to refrain from the use or threat of use of force, intervention, interference, aggression, foreign occupation and colonial domination or measures of political and economic coercion which violate the sovereignty, territorial integrity, independence and security of other States, as well as the permanent sovereignty of peoples over their natural resources;
- "5. Also call[ed] upon all States to seek, through more effective utilization of the means provided for in the Charter, the peaceful settlement of disputes and the elimination of the focal points of crisis and tension, which constitute a threat to international peace and security;
- "6. *Urge[d]* all States, in particular the nuclear-weapon States and other militarily significant States, to take immediate steps aimed at promoting and using effectively the system of collective security as envisaged in the Charter, as well as

halting effectively the arms race with the aim of achieving general and complete disarmament under effective international control, and implementing the recommendations and decisions contained in the Final Document of the Tenth Special Session of the General Assembly". ⁶⁰

7. At its forty-ninth session, the General Assembly adopted the Declaration on the Enhancement of Cooperation between the United Nations and Regional Arrangements or Agencies in the Maintenance of International Peace and Security, in which it solemnly declared:

"States participating in regional arrangements or agencies are encouraged to consider the possibility of increasing efforts at the regional level for the maintenance of international peace and security in accordance with the Charter". 61

- 8. Also at its forty-ninth session, the General Assembly adopted the Declaration on Measures to Eliminate International Terrorism, in which it, *inter alia*, solemnly declared that "acts, methods and practices of terrorism constitute a grave violation of the purposes and principles of the United Nations, which may pose a threat to international peace and security," and urged States to take a number of measures "for the speedy and final elimination of international terrorism".⁶² Paragraph 11 of the Declaration read as follows:
 - "11. All States are urged to promote and implement in good faith and effectively the provisions of the present Declaration in all its aspects".

(c) Recommendations involving actions or cessation of actions

(i) The Security Council

- 9. During the period under review, the Security Council adopted six resolutions for the maintenance of international peace and security, which imposed sanctions on certain States and were addressed to, *inter alia*, "all States" and "all States, including States not members of the United Nations". At its 2933rd meeting on 6 August 1990, the Security Council adopted resolution 661 (1990) concerning the situation between Iraq and Kuwait, 63 in which it imposed comprehensive economic sanctions on Iraq, except for supplies intended strictly for medical purposes and for certain foodstuffs. In that resolution, the Security Council:
 - "5. *Call[ed] upon* all States, including States non-members of the United Nations, to act strictly in accordance with the provisions of the present resolution notwithstanding any contract entered into or licence granted before the date of the present resolution". 64

The Security Council decided to establish a committee to monitor implementation of the resolution and called upon all States to co-operate fully with the committee in the fulfilment of its tasks.⁶⁵ It further called upon all States "to take appropriate measures to protect assets of the legitimate Government of Kuwait ...[and] not to recognize any régime set up by the occupying Power".⁶⁶

10. At its 3063rd meeting on 31 March 1992, the Security Council adopted resolution 748 (1992) relating to the Libyan Arab Jamahiriya,⁶⁷ in which it imposed, *inter alia*, an aerial and arms embargo on the Libyan Arab Jamahiriya and a reduction of staff at Libyan diplomatic missions and consular posts. In paragraph 7 of the resolution, the Security Council:

"7. Call[ed] upon all States, including States not members of the United Nations, and all international organizations, to act strictly in accordance with the provisions of the present resolution, notwithstanding the existence of any rights or obligations conferred or imposed by any international agreement or any contract entered into or any licence or permit granted prior to 15 April 1992".

The Security Council established a committee to monitor implementation of the sanctions and called upon all States to cooperate fully with the committee.⁶⁸

- 11. In resolution 883 (1993), adopted by the Security Council at its 3312th meeting on 11 November 1993,⁶⁹ the Security Council expanded the sanctions on the Libyan Arab Jamahiriya to include, *inter alia*, a freeze of some Libyan funds and financial resources in other countries and a ban on the provision to the Libyan Arab Jamahiriya of certain equipment used at oil transporation terminals and refineries. In paragraph 12 of that resolution, the Security Council:
 - "12. Call[ed] upon all States, including States not Members of the United Nations, and all international organizations, to act strictly in accordance with the provisions of the present resolution, notwithstanding the existence of any rights or obligations conferred or imposed by any international agreement or any contract entered into or any licence or permit granted prior to the effective time of the present resolution".
- 12. At its 3082nd meeting on 30 May 1992, the Security Council adopted resolution 757 (1992) relating to the situation in Bosnia and Herzegovina, 70 in which it imposed a range of economic, trade, cultural and other sanctions on the Federal Republic of Yugoslavia (Serbia and Montenegro). In paragraph 11 of that resolution, the Security Council:
 - "11. Call[ed] upon all States, including States not members of the United Nations, and all international organizations, to act strictly in accordance with the provisions of the present resolution, notwithstanding the existence of any rights

or obligations conferred or imposed by any international agreement or any contract entered into or any licence or permit granted prior to the date of the present resolution".

In paragraph 14 of the resolution, the Security Council called upon all States to cooperate fully with the committee it had established to monitor implementation of the arms embargo, which it had previously imposed on "Yugoslavia".⁷¹

13. At its 3376th meeting on 6 May 1994, the Security Council adopted resolution 917 (1994) relating to Haiti. ⁷² In that resolution, the Security Council expanded the sanctions it had previously imposed on Haiti, 73 which included an oil and arms embargo, to include, *inter alia*, a trade embargo, except for supplies intended strictly for medical purposes and foodstuffs. In paragraph 12 of the resolution, the Security Council:

"12. Call[ed] upon all States, including States not members of the United Nations, and all international organizations, to act strictly in accordance with the provisions of the present resolution and the earlier relevant resolutions, notwithstanding the existence of any rights or obligations conferred or imposed by any international agreement or any contract entered into or any licence or permit granted prior to the effective date of the measures in this resolution or earlier relevant resolutions".

The Security Council requested all States to report to the Secretary-General on the implementation of the measures contained in the resolution and earlier relevant resolutions.74

At its 3377th meeting on 17 May 1994, the Security Council adopted resolution 14. 918 (1994) concerning the situation in Rwanda, 75 in which it imposed an arms embargo on Rwanda. In paragraph 15 of the resolution, the Security Council:

"15. Call[ed] upon all States, including States not Members of the United Nations, and international organizations to act strictly in accordance with the provisions of the present resolution, notwithstanding the existence of any rights or obligations conferred or imposed by any international agreement or any contract entered into or any licence or permit granted prior to the date of the adoption of this resolution".

(ii) The General Assembly

15. During the period under review, the General Assembly adopted two resolutions under its agenda item, "The situation in the Middle East", in which the General Assembly, *inter alia*, called upon Member States to apply certain measures against Israel and:

"Urge[d] non-member States to act in accordance with the provisions of the present resolution". 76
