Text of Article 20

The General Assembly shall meet in regular annual sessions and in such special sessions as occasion may require. Special sessions shall be convoked by the Secretary-General at the request of the Security Council or of a majority of the Members of the United Nations.

Introductory note

1. The general structure of this study follows that of Article 20 in the *Repertory, Supplements Nos. 6 and 7.*

I. General survey

- 2. During the period under review, the General Assembly, in accordance with the provisions of Article 20 of the Charter and of rules 1 and 3 of its rules of procedure, convened its forty-fourth to forty-ninth sessions from 1989 to 1994 at United Nations Headquarters in New York.
- 3. In addition to the regular sessions, the General Assembly held three special sessions: the sixteenth special session in 1989, the seventeenth special session in 1990, and the eighteenth special session in 1990, also held at United Nations Headquarters.

5. Closing date of session

9. Beginning with the forty-fifth session, the General Committee abandoned its previous practice of recommending a date for the closure of the General Assembly sessions in fall. Instead, it recommended that General Assembly sessions be recessed in fall and be closed in September, the day before the opening of its next session:

... in the context of the process of renewal and reform under way and in the light of the practice at recent sessions, the General Committee recommends to the General Assembly that the forty-fourth session should recess on 18 December 1990 and close on 16 September 1991.

10. At its 3rd plenary meeting, on 21 September 1990, the General Assembly adopted the recommendation. Such recommendations were repeated by the General Committee from the forty-sixth to the forty-ninth sessions and in turn were adopted by the General Assembly.

B. Special sessions

1. Procedure for summoning

11. Article 20 of the Charter provides that special sessions "shall be convoked by the Secretary-General

at the request of the Security Council or of a majority of the Members of the United Nations".

(a) By the General Assembly

- 12. The sixteenth special session was summoned by the General Assembly at the 68th plenary meeting of its forty-third session. By its resolution 43/50 of 5 December 1988, the General Assembly decided to hold a special session "on apartheid and its destructive consequences in southern Africa".
- 13. The seventeenth special session was summoned by the General Assembly at the 43rd plenary meeting of its forty-fourth session. By its resolution 44/16 of 1 November 1989, the General Assembly decided to hold a special session "to consider as a matter of urgency the question of international cooperation against illicit production, supply, demand, trafficking, and distribution of narcotic drugs, with a view to expanding the scope of the increasing effectiveness of such cooperation".
- 14. The eighteenth special session was summoned by the General Assembly at the 90th plenary meeting of its forty-third session. The General Assembly, in accordance with its decision 43/460, decided to convene from 23 to 27 April 1990 a special session devoted to economic cooperation, in particular to the revitalization of economic growth and development of developing countries.
