# ARTICLE 24

# **TEXT OF ARTICLE 24**

1. In order to ensure prompt and effective action by the United Nations, its Members confer on the Security Council primary responsibility for the maintenance of international peace and security, and agree that in carrying out its duties under this responsibility the Security Council acts on their behalf.

2. In discharging these duties the Security Council shall act in accordance with the Purposes and Principles of the United Nations. The specific powers granted to the Security Council for the discharge of these duties are laid down in Chapters VI, VII, VIII and XII.

3. The Security Council shall submit annual and, when necessary, special reports to the General Assembly for its consideration.

# INTRODUCTORY NOTE

I. Under Article 24 the Members of the United Nations have conferred primary responsibility for the maintenance of international peace and security upon the Security Council. The primary nature of this responsibility is also reflected in the terms of Article 11(2), which provides that questions on which action is necessary shall be referred by the General Assembly to the Security Council, and in the provisions of Article 12(1), which limits the authority of the General Assembly in respect of any dispute or situation while the Security Council is exercising the functions assigned to it by the Charter.

2. As indicated in the Repertory and its Supplements Nos. 1-3, examination of the practice of United Nations organs in respect of an Article of such broad scope as Article 24 has been necessarily confined to matters which have, in practice, arisen in the proceedings of the Security Council only. The practice of the General Assembly in connexion with the maintenance of international peace and security, though relevant to a better understanding of the subject as a whole, has been dealt with under the Articles<sup>1</sup> on the functions and powers of the General Assembly. Whereas Article 24(1) prescribes the general field of responsibility of the Security Council for the maintenance of international peace and security, other Articles of the Charter, as indicated in Article 24(2), set forth the specific powers granted to the Council for the discharge of that responsibility. The analysis of the decisions of the Council in the Repertory under Article 24 has been, therefore, confined to those decisions bearing upon the main questions which arose in the proceedings of the Council in connexion with its general responsibility for the maintenance of

international peace and security, as distinct from its specific powers defined in other relevant Articles. Since no constitutional discussion on this general responsibility of the Security Council took place in its proceedings nor in those of the General Assembly during the period under review, no material has been included in the present *Supplement* as an Analytical Summary of Practice.

3. For reasons explained in the previous *Repertory* studies, the questions considered by the Security Council under its responsibility for the maintenance of international peace and security, and the decisions adopted by the Council in connexion with these questions, are presented in this study in the form of two annexes.

4. Annex I presents a list of questions which the Security Council has considered during the period under review under its responsibility for the maintenance of international peace and security as stipulated in Article 24(1) and (2). The questions, arranged in the chronological order of their inclusion in the agenda of the Security Council, are listed, with a few exceptions, under the headings appearing in the annual reports of the Council to the General Assembly. The range of questions in the list may be deemed to fall under Chapters VI and VII of the Charter.

5. Annex II consists of a tabulation of various measures provided for in positive decisions adopted by the Security Council in connexion with questions considered by it. As indicated in previous *Repertory* studies, the headings in the tabulation have been devised for convenience of presentation, and no constitutional significance should be attached to the inclusion of any particular decision under any given heading.

6. During the period under review, Article 24 was not invoked in any of the letters of submission of questions for the consideration of the Security Council.

7. Article 24(1) was explicitly mentioned in the preamble of a draft resolution<sup>2</sup> submitted to the Security Council in connexion with the situation in the Middle East. The draft resolution was however not put to the vote.<sup>3</sup>

8. Explicit and implicit references to Article 24 were made in the Security Council in connexion with the consideration of the complaint by the United States (*Pueblo* incident),<sup>4</sup> the question relating to measures to safeguard non-nuclear-weapon States parties to the Treaty on the Non-Proliferation of Nuclear Weapons<sup>5</sup> and the situation in Czechoslovakia.<sup>6</sup>

9. In the General Assembly, explicit references to Article 24 were made during the consideration of the comprehensive review of the whole question of peace-keeping operations in all their aspects;<sup>7</sup> the policies of *apartheid* of the Government of the Republic of South Africa;<sup>8</sup> the question of South West Africa;<sup>9</sup> and the question of the strengthen-

ing of international security.<sup>10</sup> In connexion with the last question the General Assembly adopted one resolution which contained language derived from Article 24. Its second preambular paragraph recalled *inter alia* "that primary responsibility for the maintenance of international peace and security is conferred by the Charter on the Security Council."<sup>11</sup>

10. Article 24(3), in conjunction with Article 15(1), places upon the Security Council the obligation to submit annual and, when necessary, special reports to the General Assembly, to render an account of the Council's discharge of the responsibility conferred upon it by Members for the maintenance of international peace and security. During the period under review, the Security Council submitted its twenty-second, twenty-third and twenty-fourth annual reports, as well as special reports. All the special reports concerned the admission of new Members.<sup>12</sup>

11. The accepted procedure with regard to the preparation of annual reports includes the following stages:

(a) Formulation of the first draft by the Secretariat;

(b) Circulation of this draft as a confidential document among the members of the Council;

(c) Discussion of proposals for changes and submission of observations at a closed meeting of the Council;

(d) Full approval at a closed meeting of the Council, following which the annual report is published as a General Assembly document and submitted for the consideration of the General Assembly.

12. As in previous years, the General Assembly did not debate the substance of the annual reports of the Security Council but merely adopted<sup>13</sup> resolutions taking note of them.<sup>14</sup>
