TEXT OF ARTICLE 26

In order to promote the establishment and maintenance of international peace and security with the least diversion for armaments of the world's human and economic resources, the Security Council shall be responsible for formulating, with the assistance of the Military Staff Committee referred to in Article 47, plans to be submitted to the Members of the United Nations for the establishment of a system for the regulation of armaments.

NOTE

1. Three Articles of the Charter refer specifically to the subject of disarmament. Article 11 provides that the General Assembly may consider, among the general principles of co-operation in the maintenance of international peace and security, specifically "the principles governing disarmament and the regulation of armaments and may make recommendations with regard to such principles". 1/ Article 26 provides that the Security Council shall be responsible for formulating plans for the establishment of a system for the regulation of armaments; while Article 47 provides that the Military Staff Committee is to "advise and assist the Security Council on all questions relating to ... the regulation of armaments, and possible disarmament".

2. The close interrelationship between the consideration of disarmament and the regulation of armaments in the Security Council and the General Assembly has been indicated in the study on Article 11.

3. In its decisions 2/ relating to the regulation of armaments, the Security Council has on no occasion made specific reference to Article 26. In its first substantive decision 3/ on the question on 9 January 1947, the Council formally accepted General Assembly resolution 41 (I), entitled "Principles governing the general regulation and reduction of Armaments", which contained certain recommendations concerning the implementation of Article 26. On 13 February 1947, the Council adopted a resolution 4/by 10 votes to none, with 1 abstention, by which it recognized that the implementation of the above-mentioned General Assembly resolution was "one of the most urgent and important tasks before the Security Council" and which took certain measures in that connexion.

4. As indicated in the study on Article 11, the General Assembly, by resolution 1 (I) established the Atomic Energy Commission to deal with the problems raised by the

discovery of atomic energy. The Security Council, by its resolution of 13 February 1947, established the Commission for Conventional Armaments to prepare proposals concerning other matters relating to disarmament. Both these commissions were superseded by the Disarmament Commission which was established by General Assembly resolution 502 (VI). 5/ While the first two commissions reported only to the Security Council, the Disarmament Commission has reported to the General Assembly as well and has received instructions from the latter. 6/ The composition of these commissions has been the same as that of the Security Council, with the addition of Canada in the cases of the Atomic Energy Commission and the Disarmament Commission, when that State was not a member of the Security Council.

5. By paragraph 7 of resolution 41 (I) the General Assembly regarded "the problem of security as closely connected with that of disarmament" and recommended the Security Council "to accelerate as much as possible the placing at its disposal of the armed forces mentioned in Article 43". The Council, in paragraph 4 of its resolution of 13 February 1947, requested the Military Staff Committee to:

"submit to it, as soon as possible, and as a matter of urgency, the recommendations for which it has been asked by the Security Council on 16 February 1946 in pursuance of Article 43 of the Charter, and as a first step, to submit to the Security Council not later than 30 April 1947, its recommendations with regard to the basic principles which should govern the organization of the United Nations armed force."

6. It was contemplated in Article 26 that the Council would be assisted by the Military Staff Committee in formulating its plans, but no assistance from the latter has been called for or rendered. 7/

7. Article 26 provides for the submission of the plans formulated by the Security Council to the Members of the United Nations. The only decision taken by the Security Council bearing on this provision has been that of 9 January 1947, <u>formally accepting</u> General Assembly resolution 41 (I) which recommended that:

"The plans formulated by the Security Council shall be submitted by the Secretary-General to the Members of the United Nations for consideration at a special session of the General Assembly. The treaties or conventions approved by the General Assembly shall be submitted to the signatory States for ratification in accordance with Article 26 of the Charter." 8/
