ARTICLE 31

TEXT OF ARTICLE 31

Any Member of the United Nations which is not a member of the Security Council may participate, without vote, in the discussion of any question brought before the Security Council whenever the latter considers that the interests of that Member are specially affected.

INTRODUCTORY NOTE

1. During the period under review, the previous practice of the Security Council concerning the application and interpretation of Article 31 was basically continued.
2. Since there was no significant constitutional discussion regarding invitations to Member States under Article 31, the present study consists only of a summary of practice and an annex containing a tabulation of invitations.
3. The summary of practice offers a brief overview of the invitations issued during the period under review, including those issued to the Palestine Liberation Organization (PLO) in line with the initial decision of the Council recorded in *Supplement No. 5*.
4. The discussion in the Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization of a proposal having a bearing on Articles 31 and 32 is also contained in the summary of practice.

SUMMARY OF PRACTICE

5. From its 2108th meeting, held on 1 January 1979, to its 2565th meeting, held on 14 December 1984, the Security Council extended 1,401 invitations to Members of the United Nations to participate in its discussions.¹ No request for participation by a Member State was denied.

6. Of the total, 1,310 invitations were extended on the basis that the interests of the Member concerned were considered "specially affected" within the meaning of Article 31 of the Charter and in accordance with rule 37 of the provisional rules of procedure of the Council. The remaining 91 were extended by the Council, in accordance with rule 37, to Members of the United Nations which had brought the matter to its attention in accordance with Article 35(1). In most cases, the President indicated that the invitation was being issued "in accordance with the relevant provisions of the Charter and rule 37 of the provisional rules of procedure"; in a few instances, explicit references to both Article 31 and rule 37 were made.²

7. The invitations extended by the Security Council to Members of the United Nations on requests submitted as a rule in letters from the Member concerned were initiated by the President. The Council continued the practice of acting without the introduction of a formal document or draft resolution and without a vote being taken. The President usually took the sense of the Council by means of a statement calling to its attention the relevant request, after

which, in the absence of objections, the State or States concerned were invited to participate in the discussion without the right to vote.

8. During the period under review, a number of invitations were extended to the Palestine Liberation Organization (PLO), in line with the initial decision of the Council at its 1859th meeting, on 4 December 1975,³ to participate in the discussion of items relating to the Middle East. In each case, the President drew the attention of the Council to the proposal by the Member State requesting the invitation of the PLO. The President noted that the proposal was not being put forward under rule 37 or rule 39 of the Council's provisional rules of procedure, but that, if adopted, it would confer on the PLO the same rights of participation as those conferred on Member States under rule 37. Twenty-seven such proposals were voted upon by the Council and adopted.⁴

9. Invited representatives of Member States continued to take part in the discussion of the question under consideration in the same manner as members of the Council, subject to the limitations on voting and on submission of proposals and draft resolutions provided for in Article 31 and in rule 38 of the provisional rules of procedure.

10. At its session in 1984, the Special Committee on the Charter of the United Nations and on the Strengthening of

the Role of the Organization, in accordance with the mandate given to it by the General Assembly,⁵ considered a proposal,⁶ which had some bearing upon Articles 31 and 32. The proposal provided, *inter alia*, that the Security Council “may hold informal consultations” when “a specific situation or dispute is brought to the attention of the Security Council without a meeting being requested”, in which case “the participation of the parties concerned should be ensured”. In support of the participation of the parties in informal consultations, it was stressed⁷ that “all States parties to a situation or dispute [should have] equal access to the Security Council”. It was also argued that direct access of the parties to a dispute to the decision-making body was a general principle of law, which had inspired Articles 31 and 32. Other representatives voiced reserva-

tions on the grounds that, in current practice, the parties to a dispute were given opportunities to make their views known. They also contended that to increase as a general rule the active level of participation at the stage of informal consultations would thwart the Council’s ability to deal efficiently and expeditiously with matters brought to its attention. The Council was entrusted to act on behalf of all Member States and must retain the possibility of meeting in seclusion if it so wished. In mandating the Special Committee for its 1985 session, the General Assembly stated⁸ that the Committee “should continue its work on the working paper”.

11. A tabulation of invitations extended to Members of the United Nations during this period is presented in the annex to the present study. As in previous studies of Article 31, invitations are listed chronologically under each agenda item and classified under two broad headings according to the basis on which they were extended. The invitations included in the tabulation represent the initial decisions of the Security Council which in each case effected the invitation.
