1. Voting and presentation of candidatures for election of a Council of twenty-seven members

In 1961, the Assembly approved an amendment to Article 50 (a) of the Convention on International Civil Aviation increasing the membership of the Council from twenty-one to twenty-seven seats. In accordance with the provisions of Article 94 (a) of the Convention, this amendment came into force on 17 July 1962, for those States which had ratified it. In 1962, the Council and Assembly considered the position of States that had not ratified the amendment and decided that such States could, at the Assembly, stand for election to one of the six additional seats on the Council and would have the right to vote at such an election.
