Dr. CHI Manjiao is Professor and Founding Director of the Center for International Economic Law and Policy, School of Law, University of International Business and Economics, Beijing. His research covers international economic law, dispute settlement, sustainable development and China's approach to international law and relations. He is the author of numerous books and articles, a frequent speaker in international law conferences, a consultant for several international organizations, and a founding editor of the *Asian Yearbook of International Economic Law*. He is, *inter alia*, Deputy Chair of the Academic Forum on investor-state dispute settlement (ISDS), Deputy Chair of China International Investment Arbitration Forum, Executive Council Member of the American Society of International Law, and Standing Council Member of the Chinese Society of International Law. He is or was a visiting professor at McGill University, the National University of Singapore, Kobe University, University of Wisconsin, Siegen University and Saarland University. In 2021, he delivered a course at the Hague Academy of International Law. He was Edwards Fellow at Columbia Law School, Senior Fellow at the Center for Global Cooperation Research of the University of Duisburg-Essen, and Visiting Fellow at the International Institute for the Unification of Private Law (UNIDROIT) and the Max Plank Institute of International Law. He is experienced in international arbitration, WTO and investment dispute settlement, treaty negotiation and policymaking. He is also a Chairperson Candidate for Trade and Sustainable Development (TSD) Expert Panel Proceedings approved by the European Union and a paneled arbitrator of many leading arbitration institutions around the world. He holds bachelor, LL.M. and Ph.D. degrees in law. His working languages are English and Chinese, with some knowledge of German and French.

大学等法学院的访问教授，德国杜伊斯堡埃森大学全球合作研究中心资深研究员，以及美国哥伦比亚大学法学院、德国马克斯普朗克国际法研究所和统一国际私法协会的访问学者，并应邀于 2021 年夏在海牙国际法研究院授课。他也有丰富的法律实践经验，曾参与处理多起 WTO 及国际投资争端，具有欧洲联盟贸易条约“贸易与可持续发展专家组”争端解决机制的首席仲裁员资格，并曾参加国际条约谈判，为国际组织、政府机构、律所及企业提供咨询，亦是新加坡国际仲裁中心、伦敦国际仲裁院、亚洲仲裁中心、中国国际经济贸易仲裁委员会和北京、深圳、上海等仲裁委员会仲裁员。他持有文学学士、法学硕士和法学博士学位，工作语言为中文和英文，并有基本的法语和德语水平。
