Born in Lima, in 1968. Lawyer by the Universidad de Lima (Peru). PhD Candidate in International Law by the *Universidad Complutense de Madrid* – UCM (Spain), Master in International Law by the *Universidad Complutense de Madrid*, and Master in Business Administration by the *Universidad San Ignacio de Loyola* (Lima, Peru).

Professor García-Corrochano Moyano is currently the Dean of the Faculty of Law in the *Universidad Peruana de Ciencias Aplicadas* – UPC. He is Judge and President of the High Court of Administrative Responsibility, which is part of the Office of the General Comptroller of Peru, as well as an Arbitrator at the Arbitrage Center of Lima Commerce Chamber. He is a Professor of Public International Law at the Diplomatic Academy of Peru and the *Universidad Peruana de Ciencias Aplicadas* – UPC.

He held different positions at the Peruvian government, including legal advisor at the Ministry for Foreign Affairs, legal advisor and technical secretary of the Peruvian Delegation to the Brasilia Rounds on the frontier dispute between Peru and Ecuador, member of the Consultative Commission of the Minister of Foreign Affairs for the maritime frontier dispute between Peru and Chili, Ambassador-at-large for Human Rights before international human rights bodies in Washington and Geneva, Vice-Minister of Justice, and President of Human Rights National Council.

Since 1993 he has been a Professor in different universities in Peru, as well as a visiting Professor in many institutions abroad. He is a member and former president of the *Instituto Hispano Luso Americano de Derecho Internacional* – IHLADI, member of the *Asociación Española de Profesores de Derecho Internacional y Relaciones Internacionales* – AEPDIRI, member of the *Asociación Americana de Derecho Internacional Privado* – ASADIP, member of the *Association Internationale de Droit de*

la Mer – ASSIDMER, and member of the *Sociedad Peruana de Derecho Internacional* – SPDI.

Professor García-Corrochano Moyano is the co-author of the *Tratado de Derecho Internacional Público, Tomos I y II* (Lima: Thomson Reuters, 2016, 2nd Edition), and of *Las Relaciones entre Perú y China* (Lima: PUCP, 2011). He collaborated in the translation to Spanish of Paul Reuter's book *Introducción al Derecho de los Tratados* (México D.F.: FCE, 1999), as well as with the *Max Planck Encyclopaedia of Public International Law* (London: Oxford University Press, 2012). He has authored many articles in collective books and journals on Public International Law.
