INTRODUCTION

The provisional list published as document A/CN.4/14, which was prepared by the Secretary-General in consultation with the International Law Commission in pursuance of Article 26, paragraphs 2 and 3, of the latter's Statute (A/CN.4/4), was based on a tentative list (A/CN.4/8) which had been presented to the Commission. An endeavour was made to include in the provisional list at least one national organization of every Member of the United Nations and due care was taken to ensure that the provisions of paragraph 3 of Article 26 were observed in its compilation.

The present revised list has been prepared by the Secretary-General in view of the fact that some national organizations have requested to be inserted and that several organizations listed in document A/CN.4/14 apparently are no longer active.^{1/}
