ARTICLE 11

TEXT OF ARTICLE 11

1. The General Assembly may consider the general principles of co-operation in the maintenance of international peace and security, including the principles governing disarmament and the regulation of armaments, and may make recommendations with regard to such principles to the Members or to the Security Council or to both.

2. The General Assembly may discuss any questions relating to the maintenance of international peace and security brought before it by any Member of the United Nations, or by the Security Council, or by a state which is not a Member of the United Nations in accordance with Article 35, paragraph 2, and, except as provided in Article 12, may make recommendations with regard to any such questions to the state or states concerned or to the Security Council or to both. Any such question on which action is necessary shall be referred to the Security Council by the General Assembly either before or after discussion.

3. The General Assembly may call the attention of the Security Council to situations which are likely to endanger international peace and security.

4. The powers of the General Assembly set forth in this Article shall not limit the general scope of Article 10.

INTRODUCTORY NOTE

1. Although paragraph 3 of Article 11 was explicitly invoked in the operative part of several resolutions adopted by the General Assembly during the period under review, no constitutional discussion ensued in the Assembly or in any of its Committees regarding the relevance of these decisions for the understanding of the Article.

2. The Summary of Practice contains material which has a bearing on the question of the relationship between the responsibilities of the General Assembly and the primary responsibility of the Security Council with respect to matters concerning the maintenance of international peace and security.

3. It also deals with the practice of the General Assembly with respect to disarmament and the regulation of armaments.

4. The Summary of Practice also gives an account of the criteria applied in the preparation of the annex attached to this study.¹ The annex contains in its three parts a tabulation of the decisions of the General Assembly with regard to agenda items bearing upon the general principles of co-operation in the maintenance of international peace and security, to agenda items bearing upon the principles governing disarmament and the regulation of armaments, and to agenda items bearing upon the maintenance of international peace and security.

5. As in the *Repertory* and its *Supplements Nos. 1-4*, the annex to this study² was prepared with the sole purpose of giving the reader a general view of the range and types of activities of the General Assembly bearing upon Article 11. Consequently, no constitutional significance should be attached to them.

SUMMARY OF PRACTICE

6. During the period under review, the General Assembly adopted five resolutions which contained explicit references to Article 11(3). In the first instance, the reference to that provision was contained in paragraph 4 of General Assembly resolution 3061 (XXVIII)² concerning the illegal occupation by Portuguese military forces of certain sectors of the Republic of Guinea-Bissau and acts of aggression committed by them against the people of the Republic.³

7. The General Assembly, upon the recommendation of the Fourth Committee, adopted resolution 3485 (XXX), paragraph 6 of which also invoked Article 11(3) explicitly,⁴ in connexion with the question of Timor.⁵ The General Assembly reiterated the explicit reference to this Article in three subsequent resolutions, 31/53,⁶ 32/34,⁷ and 33/39,⁸ all adopted in connexion with the same agenda item.

8. None of these resolutions led to any constitutional discussion regarding the application of Article 11 nor did they give rise to explicit references to the Article in the deliberations of the plenary or the Fourth Committee.

9. The General Assembly adopted a number of resolutions containing recommendations concerning the maintenance of international peace and security or drawing the attention of the Security Council to situations which were considered as

endangering, or likely to endanger, international peace and security, and requested the Security Council to take certain measures to deal with such matters.⁹

10. Article 11 as a whole, or one of its paragraphs, was explicitly invoked, touching on the relative competence of the Security Council and the General Assembly, during the consideration of a number of agenda items in the Assembly and in its main Committees.

11. During the twenty-fifth session, Article 11 was referred to in connexion with a number of disarmament issues,¹⁰ the consideration of measures for the strengthening of international security,¹¹ the policies of *apartheid* of the Government of South Africa,¹² the comprehensive review of the whole question of peace-keeping operations in all their aspects,¹³ the question of Namibia,¹⁴ the review of the role of the International Court of Justice,¹⁵ and the question of Korea.¹⁶

12. During the twenty-sixth session, there was a reference to the Article during the consideration of the report of the Special Committee on the Question of Defining Aggression.¹⁷ In the course of the twenty-seventh session, explicit references to Article 11 occurred in connexion with the situation in the Middle East,¹⁸ the non-use of force in international relations and permanent prohibition of the use of nuclear

weapons,¹⁹ a number of disarmament issues,²⁰ and the elimination of all forms of racial discrimination.²¹

13. Article 11 was also referred to during the twenty-eighth session in connexion with a number of disarmament issues,²² during the twenty-ninth session regarding the report of the Special Committee on the Question of Defining Aggression,²³ and during the thirtieth session in the general debate,²⁴ in connexion with a number of disarmament issues,²⁵ the implementation of the Declaration on the Strengthening of International Security,²⁶ the report of the *Ad Hoc* Committee on the Charter of the United Nations and the strengthening of the role of the United Nations with regard to the maintenance and consolidation of international peace and security.²⁷

14. At the thirty-first session Article 11 was invoked in connexion with the question of Palestine²⁸ and the comprehensive review of the whole question of peace-keeping operations in all their aspects;²⁹ at the thirty-second session, in connexion with the conclusion of a world treaty on the non-use of force in international relations, the implementation of the Declaration on the Strengthening of International Security, the deepening and consolidation of international détente and prevention of the danger of nuclear war,³⁰ and the report of the Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization.³¹

15. During the thirty-third session, the Article was also referred to in connexion with the question of Namibia,³² the report of the Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization,³³ and the report of the Special Committee on Enhancing the Effectiveness of the Principle of Non-Use of Force in International Relations.³⁴ The Article was also invoked at the ninth special session regarding the question of Namibia,³⁵ and at the tenth special session devoted to disarmament.³⁶

16. Article 11 was also explicitly invoked in a letter³⁷ dated 27 May 1977 from the Foreign Minister of the Soviet Union addressed to the Secretary-General concerning the preparation and conclusion by the General Assembly of a world treaty on the non-use of force in international relations.

17. Since Article 11 has frequently been referred to together with Articles 10, 12, 14 and, occasionally, Article 35, the studies on these Articles should also be consulted to obtain a more comprehensive view of the constitutional issues regarding the competence of the General Assembly and of the Security Council in the maintenance of international peace and security.

A. Criteria applied in the preparation of the annex

18. The annex has been prepared with the sole purpose of giving the reader a comprehensive view of the range and types of activities of the General Assembly in the field of international peace and security; it should, therefore, not be considered as an attempt to subsume General Assembly resolutions under various areas of application of Article 11, and still less as an attempt to interpret their significance with regard to the application of Article 11.

19. The resolutions listed in the annex include those dealing with questions bearing upon the general principles of co-operation in the maintenance of international peace and security (section I), with questions bearing upon the principles governing disarmament and the regulation of armaments (section II), and with questions relating to the maintenance of international peace and security (section III). Some of the resolutions in section III were discussed in the Fourth Committee; they are included because they contain provisions which draw the attention of the Security Council to questions considered by the General Assembly, request the Security

Council to consider them, or recommend to the Security Council specific measures to deal with them.

B. Addressees of recommendations of the General Assembly bearing upon the general principles of co-operation in the maintenance of international peace and security

20. Recommendations of the General Assembly bearing upon the general principles of co-operation in the maintenance of international peace and security were addressed to all Member States,³⁸ Member States,³⁹ certain Member States,⁴⁰ all States,⁴¹ States,⁴² certain States,⁴³ Governments,⁴⁴ the Security Council,⁴⁵ all members of the Security Council,⁴⁶ and subsidiary organs.⁴⁷

C. The practice of the General Assembly with respect to disarmament and the regulation of armaments

21. The General Assembly continued, through a growing number of resolutions adopted during the period under review, to widen its efforts towards disarmament and the regulation of armaments.⁴⁸

22. In these resolutions the General Assembly addressed its recommendations to all Member States,⁴⁹ Member States,⁵⁰ certain Member States,⁵¹ all States,⁵² States,⁵³ certain States,⁵⁴ specific States,⁵⁵ all Governments,⁵⁶ Governments,⁵⁷ certain Governments,⁵⁸ specific Governments,⁵⁹ Governments which have been carrying out nuclear tests,⁶⁰ Governments conducting underground nuclear weapon tests,⁶¹ nuclear weapon States⁶² and non-nuclear weapon States,⁶³ parties concerned,⁶⁴ the Security Council,⁶⁵ all its permanent members,⁶⁶ the Conference of the Committee on Disarmament,⁶⁷ the Diplomatic Conference on the Reaffirmation and Development of International Humanitarian Laws Applicable in Armed Conflicts,⁶⁸ the Disarmament Commission,⁶⁹ specialized agencies,⁷⁰ subsidiary organs,⁷¹ and nongovernmental organizations.⁷²

23. The General Assembly addressed recommendations also to the Secretary-General.⁷³
